





2. **REGISTERED OFFICE:-**

3. **AIM AND OBJECTS OF THE TRUST.**

3. 1. To establish, maintain, administer, educational

- 3.5. To promote programmes and schemes for providing free and non-formal education to the poor and illiterate children belonging to urban slum area and backward rural area who for social or economic reasons are not attending schools and to provide the help to the effected people from epidemic flood and draught.
- 3.6. To launch programmes and schemes for the national integrity and to strengthen brotherhood among the members of the society as supplemental to government's efforts and national interest.

4. 5. That, after the death of Moulana Md. Enamul Haque or his resignation the person founder member Moulana Md. Sabir Alam will be chairman for his life.
4. 6. That, after the death or resignation of Moulana Md. Sabir Alam from the post of chairman

5. 1. The number of trustees shall not be less than five

- 6.5. To enter into contract and borrow money from Banks, Institutions or individuals, for the purpose of the trust and management of its properties and assets.
- 6.6. To appoint consultants as they may deem fit.
- 6.7. To enter into agreements with organization and individuals for execution of any projects that may be undertaken or taken over by the trust from time to time.
- 6.8. To make rules and regulations from time to time for management and conduct of affairs of the trust and its properties and assets.
- 6.9. To invest, dispose off, transfer and otherwise deal with the subject matter of the trust in such



(7) **DUTIES OF THE BOARD OF TRUSTEES**

- 7.1. The chairman shall be the executive officer of the trust, he shall discharge his duties and exercise powers, subject to the orders, directions, control and superintendence of the Board of trustees.
- 7.2. The chairman shall conduct all official correspondence under his signature and he shall have supervisory powers over all the Institutions of the trust.
